# Memorandum of Understanding (MOU)

1. This Memorandum of Understanding (MOU) is being signed between Commonwealth Local Government Forum (CLGF) having its office at 6<sup>th</sup> Floor, Millbank Tower, 21-24 Millbank, London, SW1P4QP, hereinafter referred to as Part One; And

The Institute for Democracy, Election & Good Governance (IDEGG), a wing of State Election Commission, Maharashtra having its office at First floor, New Administrative Building, Opp. Mantralaya, Hutatma Rajguru Chowk, Madame Cama Road, Mumbai-400 032, hereinafter referred to as Part Two;

MOU dated 26/09/2018 was signed by both above parties, and various activities were undertaken with collaboration and cooperation in past 2 years. Therefore it is proposed to extend the MOU, on the terms and conditions as given in following paragraphs.

- 2. CLGF i.e. Part One is an international organisation, which works to promote and strengthen local government across the Commonwealth and to encourage the exchange of best practices - through conferences, events, technical assistance, projects and research.
- 3. IDEGG i.e. Part Two is a wing of State Election Commission, Maharashtra (SECM) and has been established with the objective of generating knowledge in the field of elections to Local Self Government,

sharing of best practices, training of election managers, developing strategies for new & emerging challenges etc. State Election Commission, Maharashtra conducts elections to nearly 28,000 Local Self Governments in the State of Maharashtra (India) and returns more than 250 thousand local representatives every 5 years through more than 80 million voters. Constitutional Mandate of State Election Commission, Maharashtra is to conduct free, fair, transparent and pure elections to Local Self Governments. **IDEGG** i.e. **Part Two** is expected to help the SECM in fulfilling the above constitutional mandate.

Several leading Institutes of India like **Gokhale Institute of Politics and Economics, Pune (GIPE) & Mumbai University,** etc. while working as knowledge partners of SECM have:

- (i) carried out data-based research,
- (ii) actively participated in the various initiatives of SECM to make democracy more vibrant & inclusive, and
- (iii) helped SECM to organize events of various stakeholders etc.

### 4. Objective

Both the Parties had entered MOU for 2 years, which was signed on 26<sup>th</sup> September, 2018; for the following Objectives –

- (i) develop collaborative arrangements & systems for Better Election for Healthier Democracy, and
- (ii) create International Forum / platform for continuous exchange of ideas, best practices etc.

# 5. Proposed areas of cooperation and collaboration:

- (i) To share ideas, knowledge and best practices
- (ii) To develop strategies for tackling new and emerging challenges
- (iii) To create International platform for continuous exchange of ideas, best practices etc.

- To create system for training of election managers and their exchange
- (v) To develop system of Election Observers
- (vi) To conduct Collaborative research and new experiments etc.
- 6. Meetings: Both the parties shall meet as many times as required, but at least once a year for achieving the objectives of MOU.
- 7. Consent & Approvals: Necessary Consents / Approvals of the authorities, if required, shall be taken, by the respective parties.
- 8. Duration: Duration of this extension of the MOU shall be of 2 years from the date of signing of the document by both the parties. It may be renewed or terminated earlier by mutual agreement.
