CONSTITUTION OF INDIA.

No.MNC 11.01/CR-23/D-XI.- In exercise of the powers conferred by clause (1) of Article 243-ZA of the Constitution of India read with subsection (1), (2), (3) and (4) of section 10A of the Maharashtra Municipe Councils, Nagar Panchayats and Industrial Townships Act, 1965 (Mah XI of 1965) (hereinafter referred to as "the said Act") and of all other power enabling me in this behalf, I, Y. L. Rajwade, State Election Commissioner Maharashtra, hereby -

- (a) delegate the powers under sections, sub-sections and clauses the said Act and under rules, sub-rules and clauses of the Maharathan Municipal Councils and Nagar Panchayats Election Rules, 1966 (herein referred to as "the Election Rules") for the purpose and to the extension specified in column (2) of the schedule hereto, to the officers of the Star Government and the Municipal Councils as shown against each of them column (3) of the said Schedule; and
- (b) direct that these officers of the State Government and of the Municipal Councils shall exercise these powers subject to in superintendence, direction and control and without prejudice to the provisions of sub-section (4) of section 10-A of the said Act.
