### Order XX

#### CONSTITUTION OF INDIA.

No. SEC-1095/CR-26/95/PR/—In exercise of the powers conferred by clause (1) of Article 243-K of the Constitution of India, read with sub-sections (1) (2) and (3) of section 10A of the Bombay Village Panchayat Act. 1958 (Bom. III of 1959) (hereinafter referred to as "the said Act') and rule 44 of the Bombay village Panchayats Election Rules, 1959 and of all other powers enabling me in this behalf, and superession of Order No. SEC/VP/EL/118/94. dated the 11th October 1994 and Order No. SEC/VP/EL/236/94, dated the 25th November 1994, I> D. N. Chaudhari, State Election Commissioner, Maharashtra, hereby:—

- (a) delegate the powers under section, sub-sections and clauses of the Act, and of the rules, sub-rules and clauses of the Bombay village, Panchayats election Rules, 1959 and of the Bombay Village Panchayat (Number of Members, Division into Wards and Reservation of Seats) Rules, 1966 to or, as the case may be, authorise, for the purpose of and to the extent specified in column (2) of the Schedule hereto, the Officers of the State Government as shown against each of them in column (3) of the said Schedule; and
- (b) direct that these officers shall exercise the powers subject to my suprintendent, direct and control and without prejudice to the provision of sub-section (4) of section 10A of the said Act.
