**CONSTITUTION OF INDIA.**

No. SEC/1094/174/1994.—In exercise of the powers conferred by clause (1) of Article 243-ZA of the Constitution of India, read with sub-sections (1), (2), and (3) of section 14 of the Bombay Provincial Municipal Corporations Act, 1949 (Bom. XLI of 1949) (hereinafter referred to as "the said Act") and of all other powers enabling me in this behalf, I, D. N. Chaudhari, State Election Commissioner, Maharashtra, hereby;

(a) delegate the powers under sections, sub-sections and clauses of the said Act, for the purpose and to the extent specified in column (2) of the Schedule hereto, to the officers of the State Government or of a Municipal Corporation of a City as shown against each of them in column (3) of the said schedule, and:

(b) direct that these officers of the State Government or of a Municipal Corporation shall exercise these powers subject to my superintendence, direction and control and without prejudice to the provisions of sub-section (4) of section 14 of the said Act.
